By completing this form you have agreed to have a great summer on one of Frontier Travel Camp's Tours in 2012. All balances for tuition must be paid prior to the departure of the tour or the traveler will not be able to depart with the group. Please adhere to the following payment schedule: For any summer tour an initial deposit of **\$1,500** is due upon returning Enrollment Agreement. This will ensure that flight arrangements, hotel accommodations, and an appropriate number of staff are provided. Fifty percent of the balance is due on March 1, 2012. Payment schedules may be made with Scott Fineman, but full payment must be received by May 15, 2012. Travelers may withdraw their agreement up to 90 days prior to the tour's departure and receive a full refund less a \$250 service fee. Travelers who withdraw four to six-weeks prior to tour departure will receive a full refund with a \$1000 service charge and are responsible for irrecoverable expenses such as airline tickets, accommodations, etc. which may not be refundable. Refunds will not be given if a traveler must leave while on the tour for any reason (i.e. medical, family issues, political, etc.). Withdrawal within four weeks forfeits tuition. Traveler's Insurance covering cancellation and medical is always recommended and preferred for all NEW travelers.
